REQUIREMENTS FOR CHEERLEADER TRYOUTS AT JONES COUNTY JUNIOR COLLEGE

1. Must be enrolled in high school or Jones County Junior College
 2. High school students must have a “C” average and graduated by August, 2009.
 3. Junior college students must have a 2.00 GPA at the time of tryouts.
 4. Must enroll in at least 12 semester hours at Jones
 5. Must have a sealed letter of recommendation from high school sponsor
 6. Must have a current physical from a licensed physician.
 7. Must present completed tryout forms.
 8. Perform cheer, chant, and/or routine taught at JC workshop
 9. Co-ed must perform the following partner stunts, jumps, and gymnastics:
 - a. toss to hands, heel stretch, pop off
 - b. walk in to hands extension, full down
 - c. toss and go liberty, pop off
 - d. optional stunt (This stunt **MUST** be approved by JC sponsor at workshop)
 - e. toe touch (females only)
 - f. at least 3 standing back hand springs
 - g. round-off and at least 3 back hand springs
 - h. standing back tuck
 - i. standing back hand spring back tuck
 - j. step and go back hand spring back tuck
 - k. optional gymnastics
 - l. back hand spring back tuck
 - m. round off tumbling pass
- You may not stunt with the same partner for more than two stunts. JC Sponsor must approve all partners.
 - Only partner stunts may be attempted one additional time if partner stunt does not stick first try.
 - Spotters will be used on all partner stunts. No spotting for tumbling.
10. You are encouraged to tryout with someone who is presently trying out. A 2009-2010 JC cheerleader may be used only if approved by sponsor in advance. If someone lives more than two hours away, he/she may talk to sponsor about the possibility of trying out with someone from his/her hometown. This person will be required to attend workshops and **MUST** be approved by sponsor weeks in advance of tryouts.
 11. To increase the safety of both male and female stunters, female body weight of 110 pounds is encouraged but **NOT REQUIRED**.

12. Mascot tryouts:
 - (1) Perform a two minute skit in the Bobcat costume.
 - (2) Must provide your own tapes of music and material for skit.
 - (3) Skit should be entertaining, crowd involved, and creative. Music and dance WILL NOT be vulgar or distasteful in manner. Music and skit MUST be approved by JC sponsor at workshop prior to tryouts.

13. General Information:
 - A. Cheerleaders and mascots receive a full tuition scholarship that will cover classes taken at Jones (12-18 hours).
 - B. Practice and performance clothing is provided by the college.
 - C. Class credit will be given for cheerleading and gymnastics.
 - D. Cheerleaders, mascots, and managers must attend all summer practices, performances, and events.
