## Student Requirements:

- ✓ Student has completed at least fourteen (14) core high school units
- ✓ Student has a partial high school transcript showing at least 14 core units. Transcript must be attached  
*(Courses such as driver's education, chorus, band and physical education are not to be included in the 14 core units.)*
- ✓ Student must have a GPA of at least 3.0 on a 4.0 scale on all high school courses.
- ✓ Student must provide unconditional approval/authorization to participate in Dual Enrollment classes.
- ✓ ACT scores must be provided.  
*A composite score of 16 or above is required to be a Dual enrolled student at Jones County Junior College. An ACT score must be provided to enroll. Certain classes do require a specific score. For example a MATH score of **19** or above is required to enroll in College Algebra and an ENGL score of **17** or above is required to enroll in English Comp I.*
